### IT IS HEREBY ORDERED:

1. Pursuant to an Agreed Final Judgment Order entered on June 3, 2024, this Court ordered that Plaintiff herein deposit the final just compensation award in the amount of ONE HUNDRED FIFTY THOUSAND DOLLARS AND NO/00 DOLLARS (\$150,300.00) with the Cook County Treasurer for the conveyance of the property (the "Subject Property") legally described as follows:
