herein, the following described real estate, with the improvements thereon, including all heating, gas and plumbing ap-
paratus and fixtures, and everything appurtenant thereto, together with all rents, issues and profits of said premises, situated
in the City of Chicago County of Cook and State of Illinois, to-wit:
The South 1/4 of Lot 60 (except the East 50.13 ft. of North 9.16 ft.)
and all of lot 61 in Charles J. Fords' Subdivision of Block 18 in Su-
division of section 19 Township 40 North, Range 14 East of the Third
Principal Meridian.

Herby releasing and waiving all rights under and by virtue of the homestead exemption laws of the State of Illinois.
IN TRUST, nevertheless, for the purpose of securing performance of the covenants and agreements herein.


