#### RIDER

THIS RIDER TO PEFERRED TO AND MADE PART OF TRUST DEED DATED NOVEMBER 3, 1977 BETWEEN IRVING ATLLIPS AND DOROTHY PHILLIPS, HIS WIFE, MORTGAGORS, AND CHICAGO TITLE AND TOUST COMPANY, TRUSTEE.

Unit No. 904 as deliniated on Survey of Lot 1 in Block 1 in Baird and Warner's Subdivision of Block 12 of Gundley's Subdivision of Lots 3 to 21 inclusive and Lots 33 to 37 inclusive in 'inc Grove, a Subdivision of fractional Section 21, Township 40 North, Range 14 East of the Third Principal Meridian, in Cook County, Illinois, together with the vacated alley in said Block and the tract of land lying Easterly of and adjoinin; said Block 12 and Westerly of the Westerly line of North Shore Drive (excepting treet previously dedicated) in Cook County, Illinois (called "Property"), which survey is attached as Exhibit "A" to Declaration of Condominium Connership mode by the American National Bank and Trust Company of Chicago, as Trustee. 'n'er Trust Agreement dated February 11, 1974 and known as Trust No. 32679, recried in the Office of the Recorder of Deeds of Cook County, Illinois as Document No. 24132761, together with an undivided .143% interest in the Property (excepting from said Property all the property and space comprising all the units thereof as defined and set forth in the Declaration and Survey), together with the terments and appurtenances thereunto belonging.

The loan secured hereby is made in reliance upon the 'w ership and management by mortgagor of the mortgaged premises. Therefore, if mortgagors shall, without consent in writing of the mortgaged, convey all or part of the rougaged premises, including fixtures that are deemed part of the mortgaged premises under local law, (except to the extent permitted by the terms hereof), but expressly excluding from this Article any articles deemed chattels under local law, or if the management, ownership or control of the mortgagor shall change, so that the present morigious shall relinquish or lose their present degree of such management, ownership or control, or in the event any consentual junior or concurrent lien is attached to the roligaged premises, then all debt secured hereby shall at once become due and payable at the option of the holder of the mortgage debt. In substantial changes, or changes by reason of death, or conveyances or assignments made to members of an owner's family shall not operate to accelerate the debt, but in the event of such changes, this rause shall apply to the gruntee or assignee as if he were the mortgagor. This provision is imapplicable to transfers or the creation of consentual liens on chattels, fine mortgagee chooses to rely on its continuing chattel security in such event, what mortgagee in such event will not be required to consent or refuse consent to sac' chattel transaction. This last provision is also inapplicable to leases for two years or less that contain no option to renew or purchase or any preemption right. A consent once given under this paragraph does not exhaust this paragraph. Like consents will be needed on future transactions.

Mortgagors shall make deposits with the holder of the Note on each of the due dates of said installments of principal or interest in amounts fixed by the holder of the Note in order to maintain a fund sufficient to enable the holder of the Note to pay the general taxes assessed against the premises described herein as they accrue or become due; said deposits to be made so that the Holder of the Note shall have on deposit in advance of the due date of each installment of taxes an amount equal thereto. The holder of the Note shall not be liable for interest on such tax deposits.
