THIS INDENTURE, made this 10th day of November, 1977, between WHEELING TRUST AND SAVINGS BANK, an Illinois Banking Corporation, as Trustee under the provisions of a deed of deeds in trust, duly recorded or registered and delivered to said Bank in pursuance of a trust agreement dated the 6th day of May, 1977, and known as Trust No. 77-224, party of the first part, and Edward G. Thompson and Karen L. Thompson, his wife, of 273 Weidner Road, Buffalo Grove, Illinois, parties of the second part.

WITNESSETH, that said party of the first part, in consideration of the sum of (\$10,00) Ten and no/100 dollars, and other good and valuable considerations in hand paid, does hereby grant, sell and convey unto said parties of the second part, not in tenancy in common, but in joint tenancy, the following described real estate, situated in Cook County, Illinois, to wit:

Lot 189 in Strathmore in Buffalo Grove Unit No. 1, in Sections 5 and 6, Township 42 North, Range 11, East of the Third Principal Meridian, according to the plat thereof recorded May 3, 1967 as Document No. 20125932, in Cook County, Illinois.

Together with the cements and appurtenances thereto belonging,  
TO HAVE AND TO HOLD the same unto said parties of the second part, not in tenancy in common, but in joint tenancy, and to the proper use, benefit and  
behalf forever of said party of the second part.

This deed is executed by the party of the first part, Trustee, as aforesaid, pursuant to and in the exercise of the power and authority given to and vested in him by the terms of said Deed of Deeds in Trust and the provisions of said First Agreement above mentioned, and of every other power and authority thereunto enabling, SUBJECT, HEREBY, to: the heirs of all the lands and/or mortgaged, unpaid and real estate, debts, or credits, or claims, or all kinds of general taxes and special assessments and other liens and claims of any kind, pending litigation, if any; after the said real estate, building lines, buildings, fixtures, leases and other restrictions of record, if any; party walls, party wall eight, and party wall agreements, if any; Zoning and Building Laws and Ordinances, including but not limited to covenants, if any; easements of record, if any; and rights and claims of parties in possession.


