valuable considerations in hand paid, does hereby quit-claim and convey unto said party of the second part, as joint tenants with right of survivorship and as not as tenants in common the following described real estate, situated in Cook County, Illinois, to-wit:

Parcel 1 The Southerly 24 Feet of the Northerly 67.5 feet as measured on the easterly line of Lot 14 in the Roundtree Commons, a Subdivision in Section 25, Township 41 North, Range 10 East of the Third Principal Meridian, in Cook County, Illinois.

Grantor grants to the Grantee, his successors or assigns, as easements appurtenant to the above-described real estate the easements set forth in the Declaration of Covenants, Conditions, Easements and Restrictions dated March 29, 1977 and recorded April 5, 1977 as Document 23875739 and Grantor makes this conveyance subject to the easements hereby reserved for the benefit of adjoining parcels, which is incorporated herein by reference thereto for the benefit of the real estate above-described and adjoining parcels
