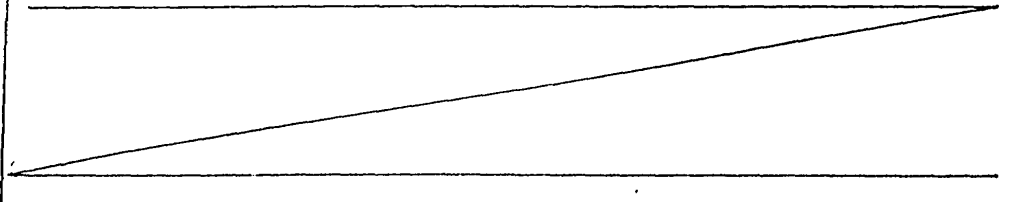
1. General real estate taxes for 1977 and subsequent years;

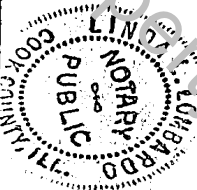
