TO HAVE AND TO HOLD the same unto said parties of the second part forever, not in tenancy in common, but in joint tenancy. SUBJECT TO: 1. Taxes for 1977 and subsequent years.

2. Declaration of Condominium recorded as document 2412/255, as amended by document 24234295.

3. Building lines and easements of record.
