Party of the first part also hereby grants to parties of he second part, their successors and assigns, as rights and easements appulierant to the above described real estate, the rights and easements for the length of said property set forth in the aforementioned Declaration, and in the Declaration of Covenants, Conditions, Restrictions and Easements for the Pheasant Creek Association recorded as Document number 22648909 ar may be amended from time to time and party of the first part reserves to itself, its successors and assigns, the rights and easements set forth in said Declarations for the benefit of the remaining property described therein.
