THIS INDENTURE, made this 28th day of November, 1977, between MAYWOOD PROVISO STATE BANK, a corporation of Illinois, as Trustee under the provisions of a deed or deeds in trust, duly recorded and delivered to said company in pursuance of a trust agreement dated the 4th day of May, 1967, and known as Trust Number 2239, party of the first part, and an undivided one-half interest in CHONG AN LEE and KYUNG AE LEE, his wife, as joint tenants and not as tenants in common, and an undivided one-half interest in JONG HWAN HYEON and KEUM SOO HYEON, his wife, as joint tenants and not as tenants in common, parties of the second part, and WITNESSETH, that said party of the first part, in consideration of the sum of TEN AND 00/100 (\$10.00) dollars, and other good and valuable considerations in hand paid, does hereby grant, sell and convey unto said parties of the second part, ~~not as tenants in common but as joint tenants~~, the following described real estate, situated in Cook County, Illinois, to-wit:

Lot 16 (except the North 21 feet thereof) and the North 27 feet of Lot 17 in Block 74 in Northwest Land Association Subdivision of the West Half of Blocks 22 and 27 and all of Blocks 23, 24 and 26 in Jackson's Subdivision of the South East Quarter of Section 11, Township 40 North, Range 13, East of the Third Principal Meridian, also Blocks 1 and 8 and Block 2 (except the East 1 acre thereof) in Clark's Subdivision of the North West Quarter of the North East Quarter of Section 14, Township 40 North, Range 13, East of the Third Principal Meridian in Cook County, Illinois

Together with the tenements and appurtenances thereunto belonging. TO HAVE AND TO HOLD the same unto said parties of the second part ~~not as tenants in common but as joint tenants~~

Subject to general real estate taxes for the year 1977 and 1978 and covenants, conditions and restrictions of record, zoning and building laws and ordinances, roads and highways, easements of record, and existing month to month tenancy of first floor apartment.

This deed is executed pursuant to and in the exercise of the power and authority granted to and vested in said trustee by the terms of said deed or deeds in trust delivered to said trustee in pursuance of the trust agreement above mentioned. This deed is made subject to the lien of every trust deed or mortgage (if any there be) of record in said county given to secure the payment of money and remaining unreleased at the date of the delivery hereof.

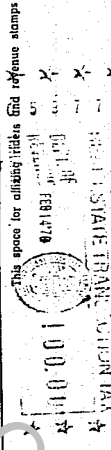
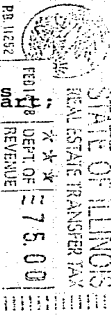
