KHAN AND SHEILA BARRON KHAN, in joint tenancy ("Grantee(s)", whose present address is 904 Michigan in the City of Evanston in the County of Cook and State of Illinois, the following described Real Estate situated in the County of Cook in the State of Illinois, to wit:
