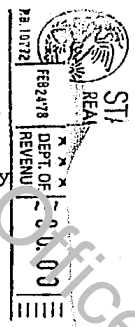
This Indenture, made this 30th day of January, 1978, between CENTRAL NATIONAL BANK IN CHICAGO, a corporation duly organized and existing as a national banking association under the laws of the United States of America, and duly authorized to accept and execute trusts within the State of Illinois, not personally but as Trustee under the provisions of a deed or deeds in trust duly recorded and delivered to said national banking association in pursuance of a certain Trust Agreement, dated the 22nd day of October, 1964, and known as Trust Number 14590, party of the first part, and ROBERT NEIL BEAULIEU, party of the second part, 6849 N. Sauganash of Chicago, Illinois, ~~mark as tenants in common but as joint tenants in common~~

WITNESSETH, that said party of the first part, in consideration of the sum of TEN and NO/100 (\$10.00) Dollars, and other good and valuable considerations in hand paid, does hereby grant, sell and convey unto said parties of the second part, not as tenants in common, but as joint tenants, the following described real estate, situated in Cook County, Illinois, to-wit:

Unit No. 1314-2S as delineated on the survey of Lots 4 and 5 in Block 4 in Evanston Park Addition, being a Subdivision of Blocks 1, 2, 3, 4, 6 and 7 in North Evanston, being in the Northeast Fractional Quarter and North One-Half of the Southeast Quarter of Section 12, Township 41 North, Range 13, East of the Third Principal Meridian, excepting from said Lots 4 and 5 the South 14 feet conveyed to the City of Evanston for Street and Alley purposes, in Cook County, Illinois, which survey is attached as Exhibit "A" to the Declaration of Condominium Ownership made by Central National Bank, as Successor Trustee to The Livestock National Bank, as Trustee under Trust Agreement dated October 22, 1964 and known as Trust No. 14590, recorded in the Office of the Recorder of Deeds of Cook County, Illinois as Document No. 24 227 554, together with an undivided 6.02% percent interest in the said parcel (excepting from the said parcel all of the property and space comprising all the units thereof as defined and set forth in the Declaration and Survey).

Grantor also hereby grants to Grantees, their successors and assigns, as rights and easements appurtenant to the above described parcel of real estate, the rights and easements for the benefit of said property, set forth in the aforementioned Declaration, and Grantor reserves to itself, its successors and assigns, the rights and easements set forth in said Declaration for the benefit of the remaining property described therein.

This deed is subject to all rights, easements, restrictions, conditions covenants and reservations contained in said Declaration the same as though the provisions of said Declaration were recited and stipulated at length herein.



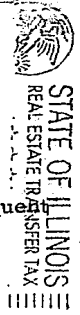

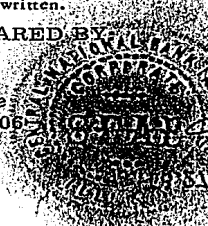

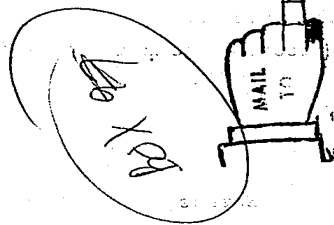
