The tenant of the subject Unit has no right of first refusal with respect to such Unit.

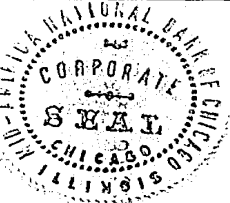

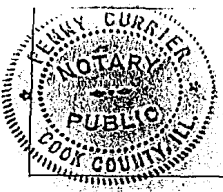
