PARCEL 1: Unit 1 area 20 Lot 4 in Barrington Square Unit 1, being a Subdivision of part of the North East 1/4 of Section 7, Township 41 North, Range 10 East of the Third Principal Meridian according to the plat thereof recorded November 14, 1969 as Document 21013529 in Cook County, Illinois.

ALSO

PARCEL 2: Easement appurtenant to the above described real estate as defined in Declaration recorded June 8, 1970 as Document 21178177 in Cook County, Illinois.

Together with the tenements and appurtenances thereto belonging, TO HAVE AND TO HOLD the same unto said parties of the second part forever, not in tenancy in common, but in joint tenancy.

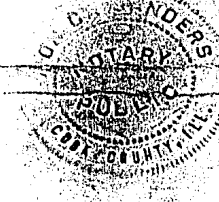
