Parcel 2: All that Part of Lot 3 (except the South 8 rods) of Assessor's division of the town of Evanston in the Southwest 1/4 of Section 30, Township 41, North Range 14 East of the Third Principal Meridian, according to the Plat thereof recorded in Book 143 of Maps, page 45, lying Easterly from a line 208 feet (measured along the North line of said lot) Westerly from and parallel with the center line of Ridge Avenue, said center line being the Easterly line of said Lot 3, in Cook County, Illinois, which survey is attached as Exhibit "A" to the Declaration of Condominium recorded as Document No. 25099513 together with its undivided percentage interest in the common elements.
