2. The land is located within the Hyde Park-Kenwood neighborhood redevelopment area established pursuant to the provisions of the neighborhood redevelopment corporation act.

And the said party of the first part, for itself, and its successors, does covenant, promise and agree, and with the said party of the second part, her heirs and assigns, that she, her heirs and assigns, shall not, in any manner incurred or charged, except as herein recited; and that the said premises, against all persons lawfully claiming, or to claim the same, by, through or under it, it WILL WARRANT AND FOREVER DEFEND.
