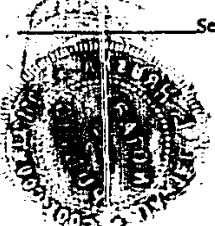
1. General real estate taxes for 1979 and subsequent years.

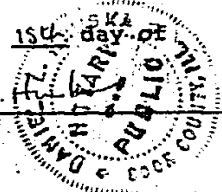
