INDENTURE

THIS INDENTURE, made this 23 day of April, 1980 between LASALLE NATIONAL BANK, a national banking association, Chicago, Illinois, as Trustee under the provisions of a Deed or Deeds in Trust, duly recorded and delivered to said Bank in pursuance of a trust agreement dated 1st day of May 1971, and known as Trust Number 42164, party of the first part, and NELLIE FINEZ, PAUL BERNSTEIN and DOLORES A. WITNESSETH, that said party of the first part, in consideration of the sum of Ten and no/100 Dollars, (\$10.00) and other good and valuable considerations in hand paid, does hereby grant, sell and convey unto said parties of the second part, not as tenants in common, but as joint tenants, the following described real estate, situated in Cook County, Illinois, to wit:

Unit No. 6E in Park View Towers Condominium, as delineated on plat of survey of the following described parcel of real estate hereinafter referred to as "Development Parcel": Lots 56 and 57 in subdivision by Andrew Staffords and Cleonhour of Blocks 1 and 2 of out-lot "A" in Wrightwood, said Wrightwood being a subdivision of the southwest 1/4 of section 28, township 40 north, range 14, east of the third principal meridian, in Cook County, Illinois.

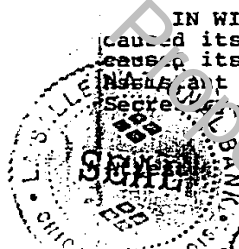
