That part of Lot 9 in Ogden and Jones Subdivision of the Bronson Tract in Caldwell's Reservation in Township 40 and 41 North, Range 13, East of the Third Principal Meridian, described as follows:

Beginning at a point on the center line of North Cicero Avenue 135.0 feet North of the North line of Peterson Avenue extended East, thence North along the center line of North Cicero Avenue 120.0 feet, thence West parallel to the North line of Peterson Avenue 290.0 feet, thence South parallel to the center line of North Cicero Avenue 120.0 feet, thence East parallel to the North line of Peterson Avenue 290.0 feet to the place of beginning, in Cook County, Illinois.


