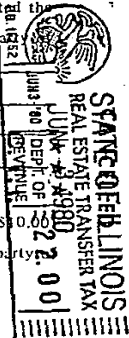
Note: Required notice having been given the tenant to the above described unit failed to exercise or waive the Right of First Refusal and vacated the unit.

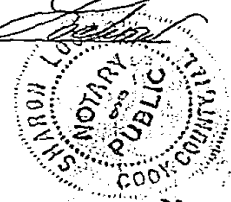
