THE COVENANTS, CONDITIONS AND PROVISIONS REFERRED TO ON PAGE I (THE REVERSE SIDE OF THIS TRUST DEED):

1. Mortgagors shall (a) promptly repair, restore or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed; (b) keep said premises in good condition and repair, without waste, and free from mechanics or other liens or claims for lien and the lien hereof, and upon request exhibits satisfactory evidence of the discharge of such prior lien to Trustee to holders of the note; (d) complete within a reasonable time any building or buildings now or at any time in process of exection upon said premises; (e) comply with all requirements of law or municipal ordinances with respect to the premises and the use thereof; (f) make no masterial alterations is depremises; each or holders of the note; (d) complete within a reasonable time any building or buildings now or at any time in process of exection upon said premises; (e) comply with all requirements of law or unanipal or other charges, and other charges as distinct premises when due, and shall, upon written request; furnish to Trustee or to holders of the note duplicate recipits therefor. Such appointment may be made either before or after sale, without near, without regard to the solvency or insolvency of Mortgagors at the time of application for such receiver and without regard to the then value of the p.m' es or whether the same shall be then occupied as a homestead entitle of any provided of the p.m' es or whether the same shall be then occupied as a homestead entitle of the pendency of such foreclosure suit and, in case of a sale and a deficiency, of ring the full statutory period of redemption, whether there be redemption or not, as well as during any further times when Mortgagors, except for the "hervention of such receiver, would be entitled to collect such tents, issues and profits, and all other powers which may be necessary or are usual it such cases for the protection, possession, control, management and operation of the premises during the whole of said period. 11. Trustee or the holders of the note shall have the right to inspect the premises at all reasonable time, and access thereto shall be permitted f

Where a release is requested of a successor trustee, such successor for any note which bears an identification number purporting to be placed thereon by a prior tru, ee "eventuer or which conforms in substance with the description herein contained of the note and which purports to be executed by the persons herei de gnated as the makers thereof; and where the release is requested of the original trustee and it has never placed its identification number on the note.
