9. Trustee or the holders of the note shall have the right to inspect if a pre-nises at all reasonable times and access thereto shall be permitted for that purpose.

10. Trustee has no duty to examine the title, location, existence or condition of the premises, or to inquire into the validity of the signatures or the identity, capacity, or authority of the signatures on the note or fast deed, nor shall Trustee be obligated to record this trust deed or to exercise any power herein given unless expressly obligated by the term, by eth, nor be hable for any acts or omissions hereinder, except in case of its own gross negligence or misconduct or that of the agents or caployees of Trustee, and it may require indemnities satisfactory to it before exercising any power herein given.

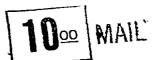
