Grantor hereby grants to Grantee, their heirs, exceutors, administrators, successors and assigns, as Limited Common Element appurtenant to the Grantee's Parcel, at Exclusive Parking Use for parking purposes in and to Indocribute deer Parking Space No. 17DE as defined and set forth in Chr. Declaration and in the Survey attached thereto.

2. The rights and interests herein granted and created shall run with the land and shall inure to the benefit of and be binding upon all present and future owners, purchasers, mortgagees, tenants, occupants and any persons acquiring any interest in the Grantee's Parcel. Reference to the rights hereby created and imposed in any deed or instruction ment of conveyance, lease, mortgage, Trust Deed or other evicance of obligation with respect to the Grantee's Parcel, shall be sufficient to grant such rights and interests to the respective grantees, lessees, mortgagees or trustees, as fully and completely as though such rights and interests were recited fully and set forth in their entirety in any such document.
