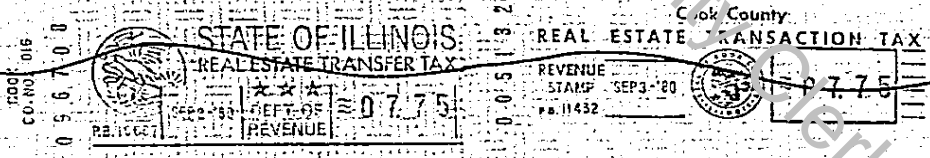
This Indenture, made this 26th day of August, 1980,

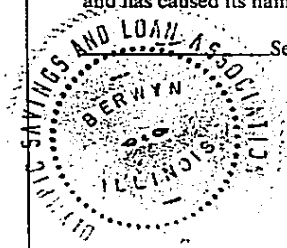


Together with all and singular the hereditaments and appurtenances thereunto belonging, or in anywise

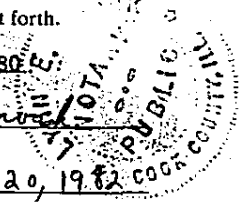
