AND the said IN SIK CHI having failed to execute and deliver such Deed within the time prescribed by said Judgment, or to place any such Deed or record;

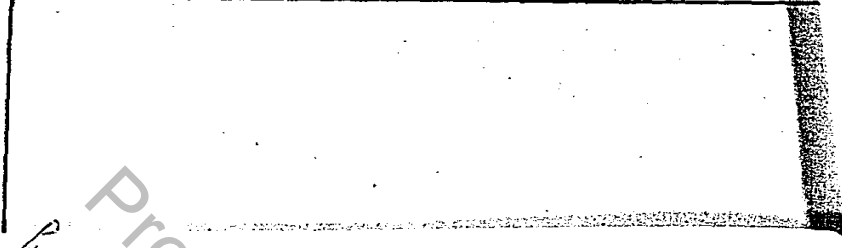

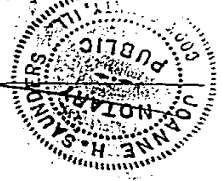
