THE FOLLOWING ARE THE COVENANTS, CONDITIONS AND PROVISIONS REFERRED TO ON PAGE 1 (THE REVERSE MIDE OF THIS TRUST DEED) AND WHICH FORM A PART OF THE TRUST DEED WHICH THERE BEGINS:

- 1. Mortgagors shall (1) keep said premises in good condition and repair, without waste; (2) promptly repair, restore, or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed; (3) keep said premises free from mechanic's liens or liens in favor of the United States or other liens or claims for lien not expressly subordinated to the lien hereof; (4) pay when due any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof, and upon request exhibit satisfactory evidence of the discharge of such prior lien to Trustee or to holders of the note; (5) complete within a reasonable time any buildings now or at any time in process of erection upon said premises; (6) comply with all requirements of law or municipal ordinances with respect to the premises and the use thereof; (7) make no material alterations in said premises except as required by law or municipal ordinance or as previously consented to in writing by the Trustee or holders of the note.
- Mortgagors shall pay before any penalty attaches all general taxes, and shall pay special taxes, special assessments, water charges, sewer
  service charges, and other charges against the premises when due, and shall, upon written request, furnish to Trustee or to holders of the note
  the original or duplicate receipts therefor. To prevent default hereunder Mortgagors shall pay in full under protest, in the manner provided by
  statute, any tex or assessment which Mortgagors may desire to contest.
- 3. Multga ors shall keep all buildings and improvements now or hereafter situated on said premises insured against loss or damage by fire, lightning and indistorm under policies providing for payment by the insurance companies of moneys sufficient either to pay the cost of replacing or repairing the une or to pay in full the indebtedness secured hereby, all in companies satisfactory to the holders of the note, under insurance policies payable, in rose of loss or damage, to Trustee for the benefit of the holders of the note, such rights to be evidenced by the standard mortgage clause to be attained to each policy, and shall deliver all policies, including additional and renewal policies, to holders of the note, and in case of insurance about the expire, shall deliver renewal policies not less than ten days prior to the respective dates of expiration.
- 4. In case of ("au" therein, Trustee or the holders of the note may, but need not, make any payment or perform any act hereinbefore required of Mortgagors in a viving and manner deemed expedient, and may, but need not, make full or partial payments of principal or interest on prior encumbrances. - 9. Upon or at any time after the filing of a complaint to foreclose this Trust Deed, the Court in which are bigger of the solvency or insolvency of Mortgagors at the time of application for such receiver and without regard to the then value of the premises. Such appointment may be made either before or after sale, without notice, without regard to the shown or insolvency of Mortgagors at the time of application for such receiver and without regard to the then value of the premises or whether the same shall be then occupied as a homestead or not and the Trustee hereunder may be appointed as such receiver. Trustee has no duty to examine the title, location, existence, or condition of the premises, nor shall Trustee be obligated to rearrd this Trust Deed or to exercise any power herein given unless expressly obligated by the terms hereof, nor be liable for any acts or omissions hereunder, except in case of his own gross negligence or misconduct or that of the agents or employees of Trustee, and he may require indemnities satisfactory to him before exercising any power herein given.

Where a release is requested of a successor trustee, such successor trustee may accept as the genuine note herein described any note which bears a certificate of identification purporting to be executed by a prior trustee hereindeer or which conforms in substance with the description herein contained of the principal note and which purports to be executed by the persons herein designated as the makers thereof; and where the release is requested of the original trustee and he has never executed any note which may be presented and which conforms in substance with the description herein contained of the principal note herein described any note which may be presented and which conforms in substance with the description herein contained of the principal note and which purports to be executed by the persons herein designated as makers thereof.
