In the event of failure of or an on(s) to comply with any of the above covenants, then Trustee is authorized at its option to attend to the same and pay he 'ii', therefor, which shall with 9% interest thereon, become due immediately, without demand. On default in any payments down accordance with the note secured hereby or any renewals or extensions thereof, or in the event of a breach of any covenant horizontained, Trustee may declare the whole indebtedness due together with interest thereon from the time of such default or breach, and my proceed to recover such indebtedness by foreclosure thereof, or by suit at law, or both, as if all of said indebtedness halt then matured by express terms.

AS FURTHER SECURITY Grantor(s) hereby assign, transfer and jet, wer to Trustee all the rents, issues and profits of said premises, from and after this date, and authorize him to sue for, collect an \re' eint for the same, to serve all necessary notices and demands, to bring forcible proceedings to recover possession thereof, to rere a the said premises as he may deem proper and to apply the money so arising to the payment of this indebtedness or any renewals contains thereof, or to any advancements made as aforesaid, and it shall not be the duty of Trustee to inquire into the validity of any sucretains, assessments, liens, encumbrances, interest or advancements.

Upon, or at any time after the filing of a bill to foreclose this trust deed, the court in which su'n bill is filed may app receiver of said premises. Such appointment may be made either before or after sale, without notice, will on t regard to the solvency or insolvency of Grantor(s) at the time of application for such receiver and without regard to the the value of the premises or whether the same shall be then occupied as a homestead or not and the Trustee hereunder may be appoint u as such receiver. Such receiver shall have power to collect the rents, issues and profits of said premises during the pendency of such for closure suit and, in case of a sale and a deficiency, during the full statutory period of redemption, whether there be redemption or not, as well as during any further times when Grantor(s), except for the intervention of such receiver, would be entitled to collect such etc., issues and profits, and all other powers which may be necessary or are usual in such cases for the protection, possession, control, manny ment and operation of the premises during the whole of said period. The Court from time to time may authorize the receiver to apply he net income in his hands in payment in whole or in part of: (1) The indebtedness secured hereby, or any renewals or e tensions thereof, or by any decree foreclosing this trust deed, or any tax, special assessment or other lien which may be or become superior to the lien hereof or of such decree, provided such application is made prior to foreclosure sale; (2) the deficiency in case of a sale are deficiency.

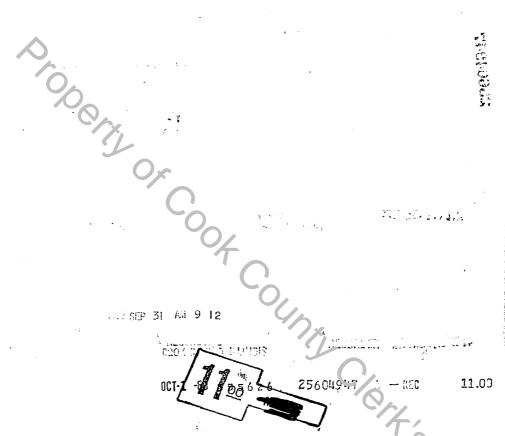
