DEED LEGAL

Unit No. 7-A-1 in 7.6 Coach Homes of Willow Bend Condominium as delineated on a survey of certain lots in GEORGETOWN of WILLOW BEND, a subdivision of part of Sections 5 and 8, Township 41 North, Range 11, East of the Third Principal Meridian as per the plat thereof recorded September 20, 1968 as Document No. 20621228 in Cook County Illinois; which survey is attached as Exhibit "A" to the Perlaration of Condominium recorded as Document No. 25259454 together with i's undivided percentage interest in the common elements.

Subject to the following:

- 1. Party of the first part also hereby grants to parties of the second part, their successors and assigns, as rights and easements appurtenant to the above described real estate; the rights and easements for the benefit of said property set forth in the aforemention d bellaration, and party of the first part reserves to itself, its successors and assigns, the rights and easements set forth in said Declaration for the benefit of the remaining property described therein.
