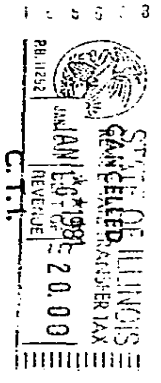
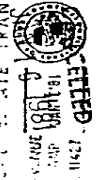
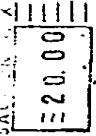
Unit No. 302 in 320 Circle Condominium, as delineated on a survey of the following described real estate:
