THE FOLLOWING ARE THE COVENANTS, CONDITIONS AND PROVISIONS REFERRED TO ON PAGE 1 (THE REVERSE SIDE OF THIS TRUST DEED) AND WHICH FORM A PART OF THE TRUST DEED WHICH THERE BEGINS:  $\cdot$ 

- 1. Mortgagors shall (1) keep said premises in good condition and repair, without waste; (2) promptly repair, restore, or rebuild any build ago or improvements now or hereafter on the premises which may become damaged or be destroyed; (3) keep said premises free from mechanics liens or tiens in favor of the United States or other liens or claims for lien not expressly subordinated to the lien hereof; (4) pay when due any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof, and upon request exhibit satisfactory evidence of the discharge of such p for lien to Trustee or to holders of the note; (5) complete within a reasonable time any building or buildings now or at any time in process of erection upon said premises; (6) comply with all requirements of law or municipal ordinances with respect to the premises and the use thereof; (7) make no material alterations in said premises except as required by law or municipal ordinance or as previously convented to in writing by the Trustee or holders of the note.
- 2. Mortgagors shall pay before any penalty attaches all general taxes, and shall pay special taxes, special assessments, water charges, sewer service charges, and other charges against the premises when due, and shall, upon written request, furnish to Trustee or to holders of the note the original or duplicate receipts therefor. To prevent default hereunder Mortgagors shall pay in full under protest, in the manner provided by statute, any tax or assessment which Mortgagors may desire to contest.
- 3. Mortgagors shall keep all buildings and improvements now or hereafter situated on said premises insured against loss or damage by fire, bit ing and windstorm under policies providing for payment by the insurance companies of moneys sufficient either to pay the cost of replacing ep- iring the same or to pay in full the indebtedness secured hereby, all in companies stafeatory to the holders of the note, under insurance eige payable, in case of loss or damage, to Trustee for the benefit of the holders of the note, such rights to be evidenced by the standard mortace are to be attached to each policy, and shall deliver all policies, including additional and renewal policies, holders of the note, and in set of isurance about to expire, shall deliver renewal policies to the days prior to the respective dates of expiration.
- Leave of default therein. Trustee or the holders of the note may, but need not, make any payment or perform any act hereinbefore required of Mo taggors in any form and manner deemed expedient, and may, but need not, make full or partial payments of principal or interest on prior encorate, and any payment of principal or interest on prior encorate. Trustee shall release this Trust Deed and the lien thereof by proper instrument upon presentation of satisfactory evid nee chat all indebtedness secured by this Trust Deed has been fully paid; and Trustee may execute and deliver a release hereof to and at the right of any person who shall either before or after maturity thereof, produce and exhibit to Trustee the principal note, representing that attiling the representation Trustee may accept as true without inquiry. Where a release is requested of a success ritude, such successor trustee may accept as the genuine note herein described any note which bears a certificate of identification purporting to be received by a prior trustee hereunder or which conforms in substance with the description herein contained of the principal note and where, our ports to be executed by the persons herein designated as the makers thereof; and where the release is requested of the original trustee and I a horse received a certificate on any instrument identifying same as the principal note described herein, he may accept as the genuine principal note herein described any note which may be presented and which conforms in substance with the description herein contained of the principal note and which purports to be executed by the persons herein designated as makers thereof.
  - 14. Trustee may resign by instrument in writing filed in the office of the Recorder or Registrar of Titles in which this instrument shall have

been recorded or filed. In case of the death, resignation, inability or refusal to act of Trustee, shall be first Successor in Trust and in the event of his or its death, resignation, inability or refusal to act, the then Recorder of Deeds of the county in which the premises are situated shall be second Successor in Trust. Any Successor in Trust hereunder shall have the identical title, powers and authority as are herein given Trustee, and any Trustee or successor shall be entitled to reasonable compensation for all acts performed hereunder.

This Trust Deed and all provisions hereof, shall extend to and be binding upon Mortgagors and all persons claiming under or through Margagors, and the word "Mortgagors" when used herein shall include all such persons and all persons at any time liable for the payment of the indehtedness or any part thereof, whether or not such persons shall have executed the principal note, or this Trust Deed.
