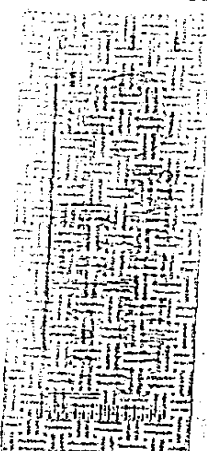
PARCEL 2:

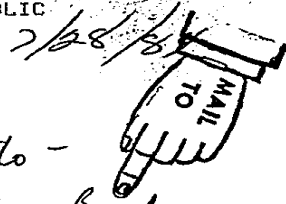
