TOGETHER with all improvements, tenements, easements, fixtures and appurtenances thereto belonging, and all rents, issues and profits thereof for so long and ining all such times as Granton(s) may be entitled thereto (which are pledged primarily and on a parity with said real estate and not secondarily) and all apparatus, equipment or articles now or hereafter therein or thereon used to supply heat, gas, air conditioning, /ater, light, power, refrigeration (whether single units or centrally controlled), and ventilation, including (without restricting the foregoing), screens, window shades, storm doors and windows, floor coverings, awnings, stoves and water heaters. In the event of failure of Grant (s) to comply with any of the above covenants, then Trustee is authorized at its option to attend to the same and pay the b. is therefor, which shall with 9% interest thereon, become due immediately, without demand. On default in any payments due in acc dance with the note secured hereby or any renewals or extensions thereof, or in the event of a breach of any covenant herein or ained, Trustee may declare the whole indebtedness due together with interest thereon from the time of such default or breach, and mry rrocced to recover such indebtedness by foreclosure thereof, or by suit at law, or both, as if all of said indebtedness had then mati red by express terms.

AS FURTHER SECURITY Granton(s) hereby assign, transfer and set ve ω Trustee all the rents, issues and profits of said premises, from and after this date, and authorize him to sue for, collect and receipt for the same, to serve all necessary notices and demands, to bring forcible proceedings to recover possession thereof, to rerent the said premises as he may deem proper and to apply the money so arising to the payment of this indebtedness or any renewals or extensivas the reof, or to any advancements made as aforesaid, and it shall not be the duty of Trustee to inquire into the validity of any such 'axes, e sessments, liens, encumbrances, interest or advancements.
