I during any further times when Granton(s), except for the intervention of such receiver, would be entitled to collect such rent, is as and profits, and all other powers which may be necessary or are usual in such cases for the protection, possession, control, my lar liment and operation of the premises during the whole of said period. 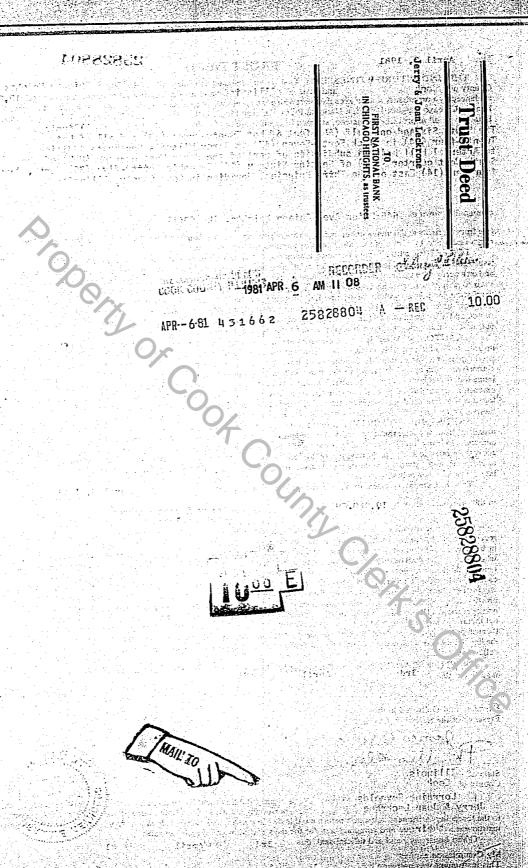
