free from all rights and handfix under and by virtue of the homestead exemption laws. Grantor(s) hereby releases and waives all rights under and by virtue of the homestead exemption laws of this State.

TOGETHER with all improvements, tenements, easements, fixtures and appurtenances thereto belonging, and all rents,

issues and profits thereof ... so long and during all such times as Grantor(s) may be entitled thereto (which are pledged primarily and on a parity with said real estar and not secondarily) and all apparatus, equipment or articles now or hereafter therein or thereon used to supply heat, gas, air conditioning, water, light, power, refrigeration (whether single units or centrally controlled), and ventilation, including (without restricting the foregoing), screens, window shades, storm doors and windows, floor coverings, awnings, stoves and water heaters. All of 1 ie for 2 going are declared to be part of said real estate whether physically attached thereto or not, and it is agreed that all similar apparatus, equipment or articles hereafter placed in the premises by the Grantor(s) or their successors or assigns shall be considered as on stituting part of the real estate.

GRANTOR(S) AGREE to pay all tages and assessments upon said property when due, to keep the buildings thereon insured to their full insurable value, to pay all prio enc in praces and the interest thereon and to keep the property tenantable and in good repair and free of liens. In the event of failth, c Grantor(s) to comply with any of the above covenants, then Trustee is authorized at its option to attend to the same and $\rho \epsilon y$ the bills therefor, which shall with 9% interest thereon, become due immediately, without demand. On default in any payments due in accordance with the note secured hereby or any renewals or extensions thereof, or in the event of a breach of any coven at the ein contained, Trustee may declare the whole indebtedness due together with interest thereon from the time of such default or and may proceed to recover such indebtedness by foreclosure thereof, or by suit at law, or both, as if all of said indebtedness hed then matured by express terms.

AS FURTHER SECURITY Granton(s) hereby assign, transfo and set over to Trustee all the rents, issues and profits of said premises, from and after this date, and authorize him to sue for, college and receipt for the same, to serve all necessary notices and demands, to bring forcible proceedings to recover possession thereof, or gent the said premises as he may deem proper and to apply the money so arising to the payment of this indebtedness or any react and of extensions thereof, or to any advancements made as aforesaid, and it shall not be the duty of Trustee to inquire into the validity of any such taxes, assessments, liens, encumbrances, interest or advancements.

Upon, or at any time after the filing of a bill to foreclose this trust deed, the court in which ruch bill is filed may appoint a receiver of said premises. Such appointment may be made either before or after sale, without not 💁 without regard to the solvency or insolvency of Grantor(s) at the time of application for such receiver and without regard to tle then value of the premises or whether the same shall be then occupied as a homestead or not and the Trustee hereunder may be appe in ed as such receiver. Such receiver shall have power to collect the rents, issues and profits of said premises during the pendency of cuch foreclosure suit and, in case of a sale and a deficiency, during the full statutory period of redemption, whether there be redemption (no.) as well as during any further times when Granton(s), except for the intervention of such receiver, would be entitled to collect such rents, issues and profits, and all other powers which may be necessary or are usual in such cases for the protection, possession, __ar_.l, __nanagement and operation of the premises during the whole of said period. The Court from time to time may authorize the receiver to apply the net income in his hands in payment in whole or in part of: (1) The indebtedness secured hereby, or any renewals or extensions thereof, or by any decree foreclosing this trust deed, or any tax, special assessment or other lien which may be or becon est perior to the lien hereof or of such decree, provided such application is made prior to foreclosure sale; (2) the deficiency in case of a sale and deficiency.
