Gaines, and Sylvia Gaines his wife as joint tenants and not as tenants in common, 8030 S. Cottage Grove, Chicago, Ill. (hereinafter referred to as "Grantee(s)"), all interest in the following described real estate.

The West 42 feet of Lots 1 and 2 and the West 42 feet of the North 20 feet of Lot 3 in Block 1 in Hartrich's Resubdivision of Block 1 and 2 in Fernwood Park Subdivision of the East 1/4 of the S.W. 1/4 of Section 9, Township 37 North, Range 14, E. of the Third Principal Meridian, in Cook County, Illinois, commonly known as 411 W. 99th Street, Chicago, Illinois.

SAID CONVEYANCE is made SUBJECT to all covenants, restrictions, easements, reservations, conditions and rights appearing of record against the above described property; also SUBJECT to any state of facts which an accurate survey of said property would show.
