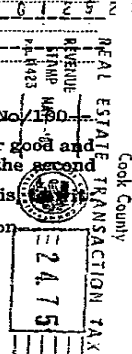
This Indenture, Made this 21st day of May 1981,

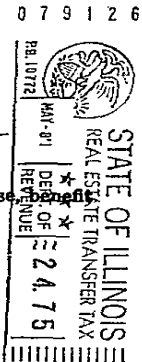

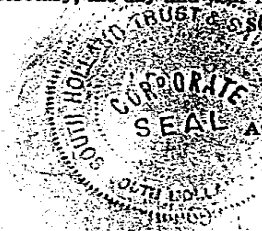

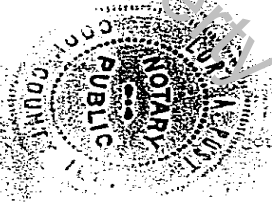
