COVENANTS, CONDITIONS AND PROVISIONS REFERRED TO ON PAGE I (THE REVERSE SIDE OF THIS TRUST DEED):

The Mortgagors shall (a) promptly repair, restore or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed; (b) keep said premises in good condition and repair, without waste, and free from mechanic's or other liens or claims for lien not expressly subordinated to the lien hereof; (c) pay when due any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof, and upon request exhibit satisfactory evidence of the discharge of such prior lien to Trustee or to holders of the agreement; (d) complete within a reasonable time any building or buildings now or at any time in process of erection upon said premises; (e) comply with all requirements of law or municipal ordinances with respect to the premises and the use thereof; (f) make no material alterations in said premises except as required by law or municipal ordinance.

2. Mortgagors shall pay before any penalty attaches all general taxes, and shall pay special taxes, special assessments, water charges, sewer service charges, and other charges against the premises when due, and shall, upon written request, furnish to Trustee or to holders of the note duplicate receipts therefor. To prevent default hereunder Mortgagors shall pay in full under protest, in the manner provided by statute, any tax or assessment which Mortgagors may desire to contest.

3. Mortgagors shall keep all buildings and improvements now or hereafter situated on said premises insured against loss or damage by fire, lightning or windstorm (and flood damage, where the lender is required by law to have its loan so insured) under polices providing for payment by the insurance companies satisfactory to the holders of the agreement, under insurance policies payable, in case of loss or damage, to Trustee for the benefit of the holders of the agreement, such rights to be evidenced by the standard mortgage claus

agreement, and without notice to Morigagors, all unpaid indebtedness secured by this Trust Deed snam, notwinstanting anything a making payment of any in this Trust Deed to the contrary, become due and payable immediately, less uncarrined charges, in the case of default in making payment of any installment on the agreement.

5. When the indebtedness hereby secured shall become due whether by acceleration or otherwise, holders of the agreement or Trustee shall have the right to foreclose the lien hereof. In any suit to foreclose the lien hereof, there shall be allowed and included as additional indebtedness in the decree for sale all expenditures and expenses which may be paid or incurred by or on behalf of Trustee or holders of the agreement for attorney's fees, Trustee's fees, appraiser's fees, outlays for documentary and expert evidence, stenographer's charges, publication costs and costs (which may be estimated as to items to be expended after entry of the decree) of procuring all such abstracts of title, title searches and examinations, title insurance policies, for rice certificates, and similar data and assurances with respect to title as Trustee or holders of the agreement may deem to be reasonably necessary ether to procedure such suit or to evidence to bidders at any sale which may be had pursuant to such decree the true condition of the title to or the value of the promises.

6. The process of any foreclosure sale of the premises shall be distributed and applied in the following order of priority: First, on account of all costs and expenses in identically and interest remaining unpaid on the agreement. Fourth, any overplus to Morigagors, their interest thereon as herein provided; third, all pricipal and interest remaining unpaid on the agreement. Fourth, any overplus to Morigagors heir heries, legal representatives or assigns, as their rights in a special and interest remaining unpaid on the agreement.
