## Trustee's Deed

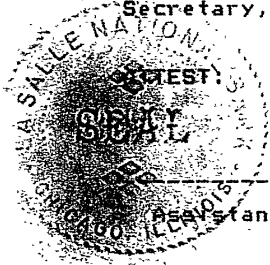
