The south 140.0 feet as measured at right angles to the south line thereof of the following described parcels taken as a tract: Lot 2 except the north 4.0 feet thereof, all of Lot 3, the 20.0 feet private roadway lying immediately easterly of and adjoining Lots 1, 2 and 3 and also the 25 foot strip of land marked "Easement for Road" and lying immediately south of and adjoining Lot 3 and lying South of and adjoining said 20.0 foot private roadway, all in or as shown on the plat of resubdivision of Lot 2 in Trecinski's Subdivision of part of the West 1/2 of the Northeast 1/4 of Section 21, Township 41 North Range 12 East of the Third Principal Meridian, in Cook County, Illinois.

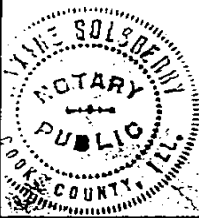
