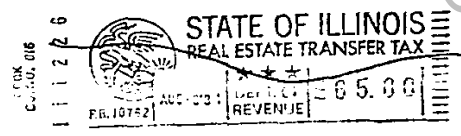

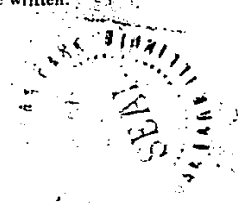


subject to all General Taxes and Special zoning and building ordinances.
