TRUSTEE'S DEED

Granter also hereby grants to Grantee, his, her or their successors and assigns, as rights and easements appurtenant to the above described real estate, the rights and easements for the benefit of said real estate set forth in the aforementioned Declaration, and Grantor reser to itself, its successors and assigns, the rights and easements set forth in said Declaration for the benefit of the remaining real estate described therein.

This Trustee's Deed is subject to all rights, easements, restrictions⊃ conditions, covenants and reservations contained in said Declaration the O same as though the provisions of said Declaration were recited and stipulated at length herein.
