THIS INDENTURE WITNESSETH, That the undersigned grantors, of Orland Park, County of Cook, and State of Illinois for and in consideration of the sum of One Dollar and other good and valuable considerations, in hand paid, convey and warrant to Merchandise National Bank of Chicago of Chicago, County of Cook and State of Illinois the following described Real Estate, with all improvements thereon, situated in the County of Cook in the State of Illinois, to wit:

Lot 198 in Silver Lake Gardens Unit 1, a Subdivision of the West 1/2 of the North West 1/4 of Section 13, Township 36 North, Range 12 East of the Third Principal Meridian, in Cook County, Illinois

hereby releasing and waving all rights under and by virtue of the homestead exemption laws of the State of Illinois. GRANTORS AGREE to pay all taxes and assessments upon said property when due, to keep the buildings thereon insured to their full insurable value, to pay all prior expenses and the interest thereon and to keep the property tenantable and in good repair and free of liens. In the event of failure of Grantors to comply with any of the above covenants, then grantee is authorized to attend to the same and pay the bills therefor, which shall with 5% interest thereon, become due immediately, without demand. On default in any payments hereunder, grantee may declare the whole indebtedness due and proceed accordingly.

AS FURTHER SECURITY grantors hereby assign, transfer and set over to grantee all the rents, issues and profits of said premises, from and after the date hereof, authorise him to sue for, collect and receipt for the same, to serve all necessary notices and demands, to bring forcible and detainer proceedings to recover possession thereof, to rent the said premises as he may deem proper and to apply the money so arising to the payment of this indebtedness, or to any advancements made as aforesaid, and it shall not be the duty of grantee to inquire into the validity of any such taxes, assessments, liens, incumbrances, interest or advancements.

In trust, nevertheless, for the purpose of securing performance of the following obligation, to-wit:

For 182 days after date for value received I (we) promise to pay to the b/d Merchandise National Bank of Chicago the sum of thirty two thousand one hundred and eight dollars and 80 cents in gold, silver or bronze coin, or its equivalent, to the office of the legal holder of this instrument with interest at 6 per cent per annum after date hereof until paid. Agree to secure the payment of said amount I (we) hereby authorize, irrevocably any attorney of any court of record in any County of the United States to appear for us in such court, at term time or vacation, at any time hereinafter and confess a judgment without process in favor of the holder of this instrument for such amount as may appear to be due thereon, together with costs, and Twenty-Five Dollars Attorney's fees and to waive and release all errors which may intervene in any such proceedings, and consent to immediate execution upon such judgment, hereby ratifying and confirming all that my (our) attorney may do by virtue hereof.

IN THE EVENT of the death, inability, removal or absence from said \_\_\_\_\_, COOK, County of the Trustee, or of his successor in this trust; and if for any like cause first successor fail or refuse to act, the person who shall then be the acting Recorder of Deeds of the County is hereby appointed to be second successor in this trust. And when all the aforesaid covenants and agreements are performed the trustee, or his successor in trust, shall release the premises to the party entitled thereto on receiving his reasonable charges.
