THIS DEED, ON THIS 1ST DAY OF SEPTEMBER, 1960, BETWEEN ALEXANDER MORTON AND TRUST COMPANY OF CHICAGO, A CORPORATION, SOLELY IDENTIFIED AS EXISTING AS A NATIONAL BANKING ASSOCIATION, UNDER THE LAWS OF THE UNITED STATES OF AMERICA, AND SOLELY AUTHORIZED TO ACCEPT AND EXECUTE TRUSTS ALONE, IN THE STATE OF ILLINOIS, AND PERSONALLY, WITHIN TRUSTEE UNDER THE PROVISIONS OF A DEED OF TRUST, IN TRUST, DULY RECITED AND DELIVERED TO SURE SHINE, THE PURCHASE OF A CERTAIN ESTATE ASSET, DATED THE 10TH DAY OF JUNE, 1960, AND KNOWN AS TRUST AGREEMENT, GRANTOR AND BYRON KIRKWOOD AND ODYSSEY KIRKWOOD, HIS WIFE.
