This deed is subject to all rights, easements, restrictions, conditions, covenants and reservations contained in said Declaration the same (s) hough the provisions of said Declaration were recited and stipulated at length hereit.

Together with the tenements and appurtenances thereunto 'e'anging.

TO HAVE AND TO HOLD the same unto said parties of the second part, not in tenancy in 0 5 8 6 common, but in joint tenancy, and to the proper use, benefit and behoof of said parties of the second part forever.

This Deed is executed pursuant to and in the exercise of the power and authority grade to and vasted in said trustee by the terms of said deed or deeds in trust delivered to said trustee in pursuance of the trust agreement above mentioned. This leed is made subject to the lien of every trust deed or mortgage (if any there be) of relord in seid county affecting the said real estate of any part thereof given to secure the payment and of money, and remaining unreleased at the date of the delivery hereof.
