JUDGE'S DEED

WHEREAS, on the 17th day of September, 1976, in case number 75D 21519, entitled HELEN CARPENTER v. JOSCHINE LAPOSTOLLE, as Associate Judge of the Land Title Section of the Circuit Court of Cook County, Illinois, in consideration of the premises, do hereby convey and quit claim all LEON CARPENTER's right, title and interest in the hereinafter described property to HELEN CARPENTER, her heirs and assigns forever, the following described premises to wit:

The South 29.7 feet of Lot 18 in Block 18 in Frederick H. Barlett's Central Chicago, a Sub-division in the Southeast 1/4 of Section 4, Township 38 North, Range 13, East of the Third Principal Meridian, in Cook County, Illinois.

To have and to hold the same, with all the appurtenances thereto belonging to the said HELEN CARPENTER, her heirs and assigns forever.

This deed is executed and delivered solely in compliance with the judgment for Dissolution of Marriage hereinabove referred to.

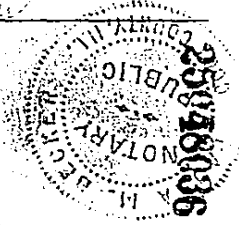

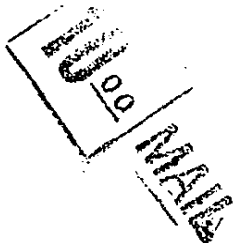
