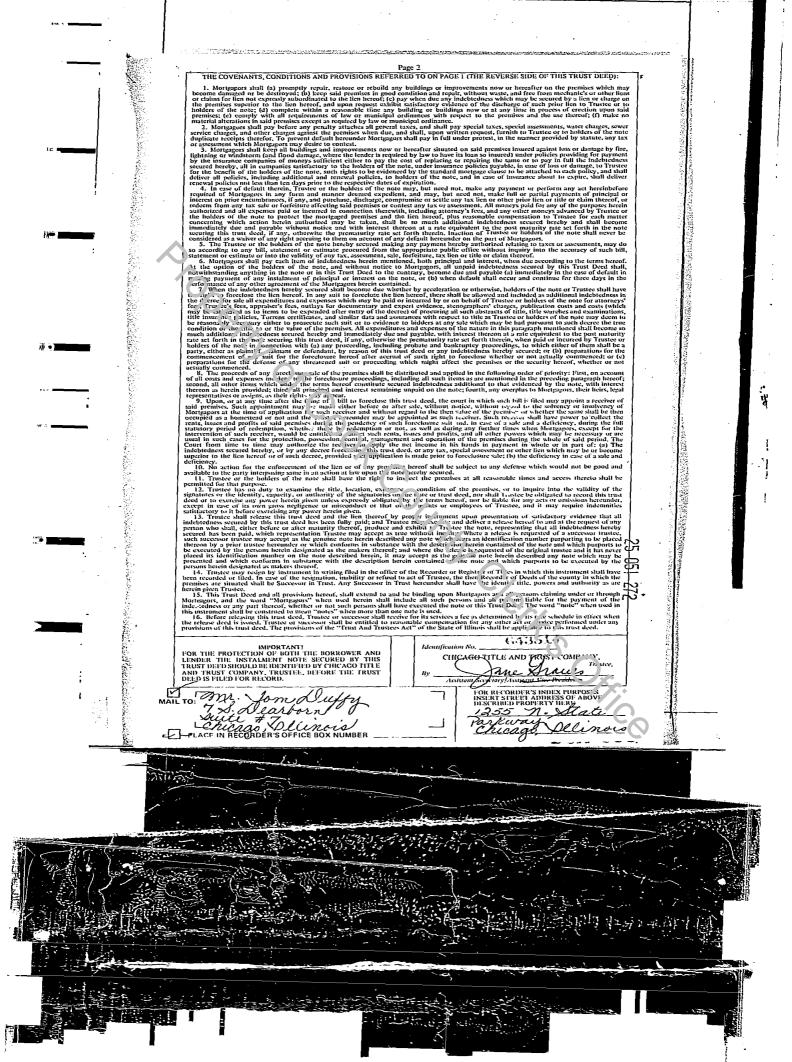

- ). The Note securing Trust Deed may be prepaid at any time without penalty whatsoever.
- 2. A default on the payment of the Note secured by this obligation shall not be declared until payment is an access over sixty (60) days.
- 3. No action shall lie under this obligation until the mortgagor/payor has be. in default for sixty (60) days.
- 4. In addition to the monthly payments of principal and interest, payor/mortgagor claim pay 1/12th of the estimated real estate taxes of the mortgaged property to Churchill Development Corporation. In the event that said real estate taxes are not paid on a timely basis, before the accrual of any penalty, the mortgagor may pay the tax, and any interest and or remalty, and set off such amounts from the principal due hereunder
- 5. If payments made here under for taxes shall not be sufficient to pay the amounts necessary as they become due, then the mortgagor shall pay the necessary amount to make up the deficiency.
