WITNESSETH, that Grantor, in consideration of the sum of Ten and no/100 (\$10.00) dollar, and other good and valuable considerations in hand paid, does hereby grant, sell, and convey unto Grantee, Eileen M. Sager, never married, the following described real estate, situated in Cook County, Illinois, to-wit:

Unit No. 703 as delineated on Survey of the Following described real estate:

Lots 11 to 14 in Bitterweet, a subdivision of Lots 13 and 16 in the School Trustees' Subdivision of Fractional Section 16, Township 40 North, Range 14 East of the Third Principal Meridian in Cook County, Illinois.

which survey is attached as Exhibit A to a Declaration of Condominium made by the American National Bank and Trust Company of Chicago, as Trustee under Trust Agreement dated November 27th, 1950, known as Trust Number, 8397, recorded in the office of the Recorder of Deeds of Cook County, Illinois, as Document No. 25009477 together with its undivided .1127 percent interest in said parcel as set forth in the Declaration (excepting from said parcel all the property and space comprising all the units thereof as defined and set forth in said Declaration and Survey).

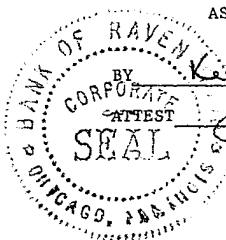

This deed is made subject to the lien of every trust deed or mortgage (if any there be) of record in said county given to secure the payment of money, and remaining unreleased at the date of the delivery hereof.
