2. Mortgagors shall pay before any penalty attaches all general taxes, and shall pay special taxes s

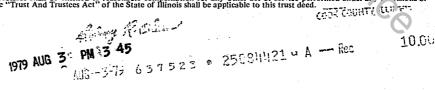
