JUDGE'S DEED

WHEREAS, on the 12th day of October, 1973 in case number 73 D 8459 entitled AIDA CISNEROS -vs- MANUEL CISNEROS, plaintiff was granted a Decree for Divorce from said MANUEL CISNEROS, wherein said judgment provided that MANUEL CISNEROS should execute and deliver to AIDA CISNEROS, a deed conveying all his right, title and interest in the real estate hereinbelow described.

And the said MANUEL CISNEROS having failed to execute and deliver such deed within the time prescribed by said judgment, or to place any such deed of record;

And said judgment further providing that upon the failure of MANUEL CISNEROS to execute and deliver such deed as aforesaid, that an Associate Judge of the Land Title Section of the Circuit Court of Cook County, Illinois, should execute such conveyance on his behalf,

Now, therefore, know all men by these presents that I, ASSOCIATE JUDGE R. DUSCHENE LA PORTA an Associate Judge of the Land Title Section of the Circuit Court of Cook County, Illinois, in consideration of the premises, do hereby convey and quit claim all right, title and interest of the said MANUEL CISNEROS to AIDA CISNEROS, her heirs and assigns forever, the following described premises, to-wit:

The South 1/2 of Lot 7 (except the North 2 feet of East 13 feet of West 43 feet of South 1/2 of said Lot 7) in W. H. Powell's Subdivision of North 423 1/2 feet of East 7 acres of Lot 6 in Circuit Court Partition of East 1/2 of North East 1/4 lying North of Milwaukee Avenue, in Section 36, Township 40 North, Range 13, East of the Third Principal Meridian, in Cook County, Illinois.

To have and to hold the same with all the appurtenances thereto belonging to the said AIDA CISNEROS, her heirs and her assigns forever.

This deed is executed and delivered solely in compliance with the Decree for Divorce hereinabove referred to.

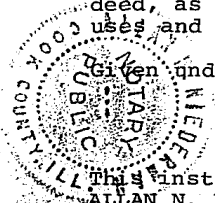
