This Indenture, **25128918** made this 23rd day of July, 19 79

between CENTRAL NATIONAL BANK IN CHICAGO, a corporation duly organized and existing as a national banking association under the laws of the United States of America, and duly authorized to accept and execute trusts within the State of Illinois, not personally but as Trustee under the provisions of a deed or deeds in trust duly recorded and delivered to said national banking association in pursuance of a certain Trust Agreement, dated the 15th day of May, 1979, and known as Trust Number 23799, party of the first part, and Mr. Gyan C. Agarwal and Sadhna A. Agarwal, his wife, 617 Wenonah, Oak Park, Cook County, Illinois &c, not as tenants in common, but as joint tenants, parties of the second part.

WITNESSETH, that said party of the first part, in consideration of the sum of (\$10.00) Ten and No/100 Dollars, and other good and valuable considerations in hand paid, does hereby convey & quit claim unto said parties of the second part, not as tenants in common, but as joint tenants, the following described real estate, situated in Cook County

Illinois, to-wit:  
Unit No. 2 E in The Randolph Condominium in Forest Park as delineated on a survey of the following described real estate: Lot 5 in Block 14 in Railroad Addition to the Town of Harlem, a Subdivision by the Calona and Chicago Union Railroad Company of the South East Quarter of Section 12, Township 39 North, Range 12, East of the Third Principal Meridian, according to the Plat thereof recorded November 26, 1958, in Book 160 of Maps, Page 15 in Cook County, Illinois; which survey is attached as Exhibit "A" to the Declaration of Condominium Ownership recorded as Document No. 25064808 together with its undivided percentage interest in the common elements. PARTY OF THE FIRST PART ALSO HEREBY GRANTS to Parties of the Second Part, their successors and assigns, as rights and easements appurtenant to the above described real estate, the rights and easements for the benefit of said property set forth in the aforementioned Declaration, and Party of the First Part reserves to itself, its successors and assigns, the rights and easements set forth in said Declaration for the benefit of the remaining property described therein. THIS DEED IS SUBJECT TO all rights, easements, restrictions, conditions, covenants and reservations contained in said Declaration the same as though the provisions of said Declaration were recited and stipulated at length herein. Tenant of the Unit did not exercise the right of first refusal.
