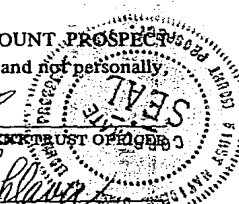
This deed is executed pursuant to and in the exercise of the power and authority granted to and vested

county remaining unreleased at the date of the delivery hereof.

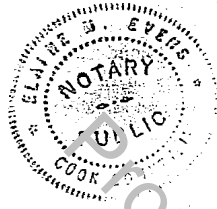
